

ORDINANCE NO. _____ OF 2024

AN ORDINANCE OF THE TOWNSHIP OF EAST LAMPETER, LANCASTER COUNTY, PENNSYLVANIA, AMENDING THE EAST LAMPETER TOWNSHIP CODE OF ORDINANCES, CHAPTER 320, WHICH REGULATES TRAFFIC AND PARKING IN THE TOWNSHIP TO INCLUDE ADDITIONAL TRAFFIC AND WARNING LIGHTS AND STOP AND YIELD SIGNS.

WHEREAS, on September 14, 1987, the Township of East Lampeter adopted Ordinance No. 116, as amended, regulating traffic and parking in the Township and repealing all prior ordinances inconsistent therewith;

WHEREAS, on May 6, 2024, by Ordinance No. 371, the Township revised, codified and consolidated its ordinances including Ordinance No. 116 such that the provisions of Ordinance No. 116 are now set forth in Chapter 320 of the East Lampeter Township Code of Ordinances;

WHEREAS, the Township is now desirous of the provisions of Chapter 320 for the purpose of adding certain traffic and warning lights and stop and yield signs along roads within the Township.

BE AND IT IS HEREBY enacted and ordained as follows:

1. Section 320-9.A of the East Lampeter Township Code of Ordinances, which establishes locations where traffic signals shall be erected or are ratified if previously erected, is amended to include the following:

Intersection of Greenfield Road and Ben Franklin Boulevard	Traffic control signal

Intersection of Greenfield Road and Hempstead Road	Traffic control signal
Intersection of Hempstead Road and Pitney Road and Oak Grove Drive	Traffic control signal
Intersection of Greenfield Road and William Penn Highway	Traffic control signal
Intersection of Route 30 and Dutch Wonderland	Traffic control signal
Intersection of Route 30 and Willowdale Drive	Traffic control signal

2. Section 320-13.A of the East Lampeter Township Code of Ordinances, which establishes stop intersections, is amended to include the following:

<u>Stop Street</u>	<u>Intersecting or Through Street</u>	<u>Direction of Travel</u>
Parkview Lane	Hobson Road	Northbound

3. Section 320-14.A of the East Lampeter Township Code of Ordinances, which establishes yield intersections, is amended to include the following:

<u>Yield Street</u>	<u>Through Street</u>	<u>Direction of Travel</u>
Sunlite Circle	Starlite Drive	Southbound

4. Chapter 320, Article II, of the East Lampeter Township Code of Ordinances, is amended to add a new Section 320-16 to establish locations for warning lights to include the following areas:

- Hartman Bridge Road south of Rockvale Road
- Route 30 Westbound east of Route 896
- Route 30 Westbound east of Ronks Road
- Witmer Fire Company, Mt. Sidney Road
- Conestoga Valley High School, Horseshoe Road
- Lancaster Mennonite School
- Route 30 east of Ronks Road
- Conestoga Valley School District, Mt. Sidney Road
- Smoketown Elementary School, Old Philadelphia Pike
- Ben Franklin Boulevard at Walnut Street Roundabout

5. All other provisions of Chapter 320, as amended from time to time, shall remain in full force and effect as heretofore adopted.

6. This Ordinance shall become effective five (5) days after the date of its enactment.
