## A. Sanitary Sewer:

i. Stauffer Run Upgrade

Mr. Cichy nothing new to report. Gorman-Rupp will be shipping the belt/sheave parts around July 11, 2025. Once they are received then Envirep will work with Township staff to schedule the installation.

#### ii. CFA Funding-

a. Oaks #2 Elimination Project

Mr. Thomas reported that he spoke to Solicitor Mr. Matt Crème, Jr. to prepare a draft letter to the property owner for the board to review.

## b. Stauffer Run PS Wet Well Lining Project

Mr. Cichy reported that the contractor Utility Services Group is getting a sewer plug to divert the flow within the pump station, before they can start the open portion of the wet well lining project.

## iii. Strasburg Pike Project

Mr. Cichy reported that they did receive comments from Penn Dot that will need to be reviewed and resubmit the revised application. ECS has completed the geotechnical investigation and preparing a report which will need to be submitted for the PA DEP Water Obstruction and Encroachment Permit application. HRG is working with Township Staff and Solicitor to obtain the necessary easements for the project.

#### iv. Kettle & Fire

Mr. Thomas informed the board that there is a meeting scheduled with the representatives of Kettle & Fire to discuss the problem. Mr. Hutchison informed that the property had about 28 Edu's approval, however the current flows are significantly higher as well as the temperature of the waste if extremely high.

## A. Sanitary Sewer:

i. Partners Meeting

Mr. Hutchison shared the discussion at the meeting. Mr. Cichy discussed the city projects and the cost. Mr. Patel discussed his concern that the city projects seem to be a significant portion of our budget. Mr. Hutchison informed that there has been discussion at the Partners' Meeting to escrow money as the project progresses verses having to escrow all funds up front.

  - 5. City Escrow agreement Amendment No. 3 for the WWTP Special and Emergency Capital Improvements (Revised Allocations), Authority share is \$37,325.00
