#### Reports

- a. Grounds, Buildings & Trails:
  - i. Mr. Thomas stated the water fountain is installed & in use. The crew has just been doing general repairs & getting ready for the fall fertilizing and spraying. Things are starting to wind down. Mr. Thomas stated fall ball should be just about over for the season.

#### b. Recreation:

- i. Ms. Cleveland stated a few programs have wrapped up. Zumba class at Lafayette. Lancaster Bird Club had a bird walk at Community Park, 18 individuals attended. There is a lot coming up. Fall festival will take place October 4<sup>th</sup>, there will be pumpkin painting, crafts, games, popcorn, and apple cider. CV Seeds will be volunteering, CV High School Students, as well as Township Employee's. There will be 2 more Zumba Classes, Yoga will continue indoors. Movie Night will be October 24th and will include a candy scramble as well. Our friends from Alliance Towing will be helping with the candy scramble as well as supplying hamburgers & hotdogs. The movie being shown will be Coco. Planning a Pajama book nook at the Township building. November 3<sup>rd</sup> will be wreath making at Lafayette fire company. November 5<sup>th</sup> the attorney general's office will be hosting a senior scam at the Township building in the afternoon, this same day there will be a holiday ornament decorating at Cv High School in the ceramics room. There is a group that will provide the ornaments, once painted they will take them back to their location, put in kiln and then bring back to Township office for distribution. On November 10<sup>th</sup> there will be a Sourdough Baking Starter Bread Class at CV High School in the family & consumer arts classroom. December 13<sup>th</sup> is the New York Bus trip. Also, will be partnering with CV for their bonfire as well as Trunk or Treat at Tanger on October 27th. Ms. Cleveland stated she will have the end-ofyear report for the pavilion rentals at the October meeting. Ms. Cleveland stated at this point \$19,000.00 has been brought in. Mr. Hollingsworth stated he received an email called Friends of Conestoga Valley. He stated it sounds like it went to all grads of CV, thought maybe it would be a good way to connect to residents. Ms. Tyson thought maybe it came from the Education Foundation. Ms. Cleveland asked for the contact information for the person who sent the email.
- ii. Mr. Chretien asked if we heard anything from Upper Leacock concerning help with supporting their pool. Mr. Thomas stated he had not heard anything.
- iii. Ms. Piestrak stated Township has officially purchased 89 Strasburg Pike on September 12<sup>th</sup>.
- iv. Ms. Piestrak stated the Oakview Trail is scheduled to begin on October 13<sup>th</sup>. Ms. Tyson asked how long construction will take, Mr. Thomas advised April 2026 it should be completed. They would like to get as much done on the Strasburg Pike side this winter as possible since the other portion is over on Greenland Drive and will involve paving, wanting to stay away from the winter months. If the weather stays good, they are going to keep moving. Mr. Chretien ask who owns the ramp that goes into Walmart, Mr. Thomas stated that is Walmart property and is used by the Amish.

### **Public Comment**

- ii. Mr. Wagner asked if the Oakview Trail is the one referenced on the Streetscape Plan. Mr. Thomas stated the trail would go from Strasburg Pike, to entrance of Flory Park, out to Greenland Drive, over to Oakview to Route 30.
- iii. Mr. Wagner asked what the status is at Gibbons Park. Mr. Thomas stated that the plan has a trail, bridge over Millcreek and a trail on the other side. There is about 15 acres there, but nothing can be built due to being on a flood plain. Township is in the process of filing for grants whenever one becomes available. Ms. Tyson stated they are trying to get a canoe launch with a terminal launch at Flory Park by the dam at the Old Mill Shop.
