Old Business

A. Fertility Pump Station

Mr. Cichy gave update that a few warranty items are being fixed. It was noted that one of the pump is making a loud noise occasionally. It was discovered that there is a water hammer effect that is causing the loud noise. The check valve is slamming during the ramp down of the pump. Staff will keep an eye on this for now.

B. Generators

Mr. Thomas reported that they picked up the two generators and were storing them and will use them as the older once start failing.

New Business:

A. Warrington (Keystone)

Ms Dianne Frame presented the board with a proposed schedule for the pump station. The schedule calls for construction to start January 9, 2012 and completion by June 29, 2012. The board thanked Ms. Frame for the schedule.

Mr. Chillas explained that since Mr. Bob Long past away that Jennifer that worked in their office is with another firm that does municipal bonds. She will be sending a letter to the Board requesting that she be considered to manage the files. The board will wait for her letter.

Mr. Stumpf had a few questions in regard to the billing in the township. Mr. Hutchison explained that the ordinance outline that based on the type of use of the property is what determines whether the sewer bill is fixed or based on the water usage.
