# June 15, 2015

The East Lampeter Township Board of Supervisors met on Monday, June 15, 2015, at 7:30 p.m. at the East Lampeter Township Office: 2250 Old Philadelphia Pike, Lancaster, PA 17602. The meeting was called to order by Mr. John Blowers, Chairman and was followed by the Pledge of Allegiance. In addition to Mr. Blowers, supervisors present were: Mr. David Buckwalter, Mr. Glenn Eberly, Mr. Corey Meyer and Mr. Ethan Demme. Also present was Mr. Ralph Hutchison, Township Manager.

# Minutes of the June 1 2015 Regular Meeting

Chairman Blowers asked if there were any additions or corrections regarding the minutes of the June 1, 2015 regular meeting as prepared.

A motion was made by Mr. Buckwalter to approve the minutes as presented. Mr. Meyer seconded the motion and it was passed by unanimous voice vote.

# Bills:

Chairman Blowers indicated that bills to be paid from various funds in the amount of \$385,858.03 were presented for payment. Mr. Blowers discussed some of the larger items included in that amount was a payment in the amount of \$171,268.09 to the City of Lancaster for the undisputed 2013 sewer operating costs, a payment in the amount of \$11,416.14 to Hospitality Associates of Lancaster LP (Lancaster Host) to reimburse for court ordered 2013 Real Estate Tax Assessment reduction resulting in overpayment, a payment in the amount of \$14,700.00 to the four Township Volunteer Fire Companies for a total of \$58,800.00, and a payment in the amount of \$14,375 for half of the 2015 budgeted contributions to the local libraries: \$7,331.25 to Lancaster Public Library, \$4,168.75 to Manheim Township Library, and \$2,875.00 to Pequea Valley Public Library/Intercourse Branch, and the creation of an escrow account in the amount of \$25,680.77 to cover possible future disputed fees associated with the 2013 sewer operating costs.

A motion was made by Mr. Meyer and seconded by Mr. Eberly to approve the payment of the bills as listed in the amount of \$385,958.03. The motion was passed by unanimous voice vote.

Emergency Services Committee Apparatus Presentation re: Lafayette Fire Company – Squad Vehicle (2016)

Chairman Blowers stated that the Emergency Services Committee heard the apparatus presentation at their last meeting. He stated that representatives from the Lafayette Fire Company are present to give the same presentation in regards to the purchase of a 2016 Squad vehicle.

Mr. Bruce Paul, East Lampeter Township Emergency Services Committee Chairman, spoke on behalf of the Emergency Services Committee and Lafayette Fire Company in regards to the purchase of a new squad under the 2015 Equipment Apparatus Replacement Program approved by the Supervisors. He stated that the new squad will cost approximately \$150,000. He stated that they are requested \$90,000 from East Lampeter Township for their 60 percent of the apparatus funding program. He stated that Lafayette contributed \$60,000 of the funding. He stated that the Lafayette Fire Company Relief Association will maintain ownership of the vehicle and maintain and repair the vehicle. He stated that Lafayette will gain some short term debt while waiting for distribution of relief funds with an anticipated payoff date in October 2016. He stated that Lafayette plans on retaining the old squad for general use and that the Lafayette Fire Company Relief Association will maintain ownership for the maintenance and repairs. He stated that the costs for 2014 for fuel was \$978 and insurance was \$596. He explained that the new squad will play a larger role in responses as Lafayette downsizes their fleet.

Mr. Dave Keens, Deputy Chief of Lafayette Fire Company and Lafayette's representative to the ESC, reviewed a power point presentation. He stated that the current squad is 25 years old and has little equipment storage. He stated that it is used for traffic control, errands and cardiac arrests. He stated that they are proposing to replace the old squad with a new squad designed with increased equipment and towing capacity and the ability to handle more incident types. He reviewed the history of selection process for the squad and the funding sources available. He stated that they would need to make a payment in July of \$15,000 when signing the contract and they would need 40 percent of the total cost in November and payment in full proposed for January 2016. He stated that the two things needed from the Township are the approval of the unit with the \$90,000 from the Township and the concession on the building loan agreement.

Mr. Scott Hershey, Chief of Lafayette Fire Company, told the Board how the squad will be used. He stated that the new squad will be a primary use vehicle. He stated that it can be used in place of the larger equipment for minor emergency calls. He reviewed the type of equipment that the new squad will hold enabling the fire company to respond to more calls. He stated that Lafayette would like to keep the old squad and use it as a non-primary vehicle enabling them to keep the new squad in service.

Mr. Blowers thanked the gentlemen for their presentation. Mr. Blowers summarized the presentation stating that the ESC is recommending approval for the Lafayette Fire Company to buy a 2016 squad under the new funding plan where the Township pays 60 percent and the Fire Company pays 40 percent of the costs. He stated that Lafayette is asking for the Boards approval for the purchase and concessions on the building loan agreement to be able to take out a bridge loan. Mr. Blowers asked if the bridge loan is definitely needed. Mr. Hershey stated no that they could pay up front using their general funds but then the fire company would own it but if they wait for the relief funds the Relief Association would own and maintain the vehicle. He stated that the general fund is usually used for the larger equipment.

Mr. Blowers asked Mr. Hutchison about the building agreement. Mr. Hutchison stated that if the Board wants to amend the agreement he suggests they talk to the solicitor to draft a new agreement. The Board and the members of Lafayette Fire Company discussed time frames for the project and payment options.

The Board asked for time to discuss options and have Lafayette return to the July 13, 2015 Board of Supervisors meeting. Mr. Blowers stated that under the new agreement the Township pays for the fuel and insurance costs for each fire company vehicles but is hesitant to pay for an additional vehicle. Mr. Hershey stated that Lafayette could support the extra vehicle's fuel and insurance costs.

# Old Business:

 Request for Time Extension to Record Conditionally Approved Plan #13-27 – Esch: 2985 Lincoln Highway East

Chairman Blowers asked if anyone was present for this agenda item. No one was present.

Mr. Hutchison stated that the applicant recently received their PennDOT Highway Occupancy Permit and is in the process of obtaining their financial securities for the improvements to be able to record the plan. He stated that the applicant is asking for a six month time extension.

Mr. Buckwalter made a motion to approve the request for a 6 month time extension to record the conditionally approved plan #13-27 for Ephraim Esch at 2985 Lincoln Highway East. Mr. Eberly seconded the motion and it was passed by unanimous voice vote.

b. Time Extension Proposal – Beiler Land Development Plan #15-9: 380 Beechdale Road

Chairman Blowers asked if anyone was present for this agenda item. No one was present.

Mr. Hutchison stated that the applicant is requesting a 90 day extension. He stated that the Township has provided review comments with no response from the applicant. He stated that the applicant has failed to appear at the last two Planning Commission meetings. Mr. Buckwalter asked if the Board has granted time extensions to the applicant previously. Mr. Hutchison stated that they have granted time extensions for the address but not for this plan in particular. Mr. Hutchison stated that the Planning Commission recommends against the time extension which means the Board would have to act to reject the plan because they are out of time. Mr. Hutchison stated that the Township provided review comments and the applicant has not addressed those comments.

Mr. Demme commented about the letter stating the applicant is granting the Township an extension to review. Mr. Hutchison explained that the Municipal Planning Code is set up that when an application is received by the Township the Township has a period of time to review and act on the plan. He stated that when there has been no action, in this case because the applicant isn't ready, the applicant has to give the Township more time for the process to continue. He stated that if the Township doesn't act in a period of time, the application is deemed approved and the applicant doesn't have to change their plan it just gets recorded.

Mr. Buckwalter made a motion to deny the Beiler Land Development Plan #15-9 for 380 Beechdale Road based upon the Township Engineers review comments. Mr. Meyer seconded the motion and it was passed by unanimous voice vote.

# New Business

a. Request for ECHO Agreement – Stoltzfus: 385 Willow Road

Chairman Blowers asked if anyone was present for this agenda item. Mr. John Stoltzfus was present.

Mr. Stoltzfus stated that he is requesting to install an ECHO unit on his property at 385 Willow Road.

Mr. Hutchison asked if it was a modular unit and who would be living in it. Mr. Stoltzfus replied that it is a modular unit and his wife and he would be residing in it and his parents and their children would be living in the house. Mr. Hutchison asked if Mr. Stoltzfus is aware that when the modular is no longer need it will need to be removed. Mr. Stoltzfus responded that he thought that the kitchen stove had to be removed. Mr. Stoltzfus asked if he has to notify the Township every year regarding the ECHO unit. Mr. Hutchison confirmed that notification is required to confirm the occupants. Mr. Buckwalter stated that if the occupancy changes in the ECHO unit, Mr. Stoltzfus would need to have a new agreement.

Mr. Meyer made a motion to approve the ECHO Agreement for John and Mary Stoltzfus at 385 Willow Road. Mr. Demme seconded the motion and it was passed by unanimous voice vote.

Mr. Eberly commented that he feels the Board needs to look at modifying the terms of ECHO agreements in regards to modular units versus kitchen removals. The Board had a discussion about ECHO units and the difference between an ECHO unit and an apartment. Mr. Blowers stated that he would like to look at the ECHO agreements to determine if the Board is handling them the way they intended.

# Other Business:

a. Reimbursement Agreement re: Services to be provided to 2015 USWO

Mr. Hutchison explained that they crafted the document with the help of the USGA to outline the terms for the costs the Township is occurring in response to the providing of services during the week of the Open. He stated he is waiting on the final language from Mr. Deach but recommends the Board consider taking action on this item since it is the last regular meeting before the tournament begins. Mr. Hutchison summarized the agreement by saying the Township would be asking for reimbursement from the USGA for police overtime costs, preparation for signage costs, and installation and removal of signage costs. He stated that the Township is not asking for the costs related to vehicle usage or man hours involved in the planning and preparing for the tournament.

Mr. Blowers asked if Manheim Township is handling the situation the same way as East Lampeter. Mr. Hutchison stated that it is similar but they have additional items to be considered since the main entrance is in their Township.

Mr. Buckwalter made a motion to approve the USGA Reimbursement of Costs Agreement for the 2015 USWO. Mr. Demme seconded the motion and it was passed by unanimous voice vote.

b. Consideration of Bids for Bowman Road Culvert Replacement Project

Mr. Hutchison explained that the Bowman Road Culvert failed last summer and the road has been closed. He stated that the Township is now ready to replace the culvert and has received 8 bids with the low bid coming from Abel Construction Company Inc. for \$212,972.15. He stated that the Township engineer and Township staff recommend the Board approve the low bid to Abel Construction. Mr. Hutchison also stated that the project should be completed before school starts. The Board and Mr. Hutchison discussed the possible breakdown of the project costs.

Mr. Demme made a motion to approve the bid of \$212,972.15 from Abel Construction for the Bowman Road Culvert Replacement Project. Mr. Eberly seconded the motion and it was passed by unanimous voice vote.

# Public Comment:

Mr. Bill Adams, a resident from Spring Dell Road, stated that the bridge across the Conestoga will be closed for a year. He feels it will be a big inconvenience and a safety issue. He is asking for support in the installation of a temporary traffic light at Willow Road and Route 23 during construction. Mr. Hutchison commented that the Township met with the County Engineer who stated that the Township would be involved in the design process and detour routes.

Mr. Jeffrey Cutler, Township Tax Collector, spoke regarding the Disable Veteran's Real Property Tax Exemption certificates. He discussed a conversation he had with Linda Jones, a Veteran Services Specialist, regarding deceased veterans and their spouses and their ability to apply to the program. Mr. Hutchison commented that the Township does not play a role in the determination of these tax exemptions.

# Adjournment:

A motion was made by Mr. Meyer and seconded by Mr. Demme to adjourn the meeting. The motion was passed by unanimous voice vote. The next regularly scheduled meeting is to be held on Monday, July 13, 2015 beginning at 7:30 pm.

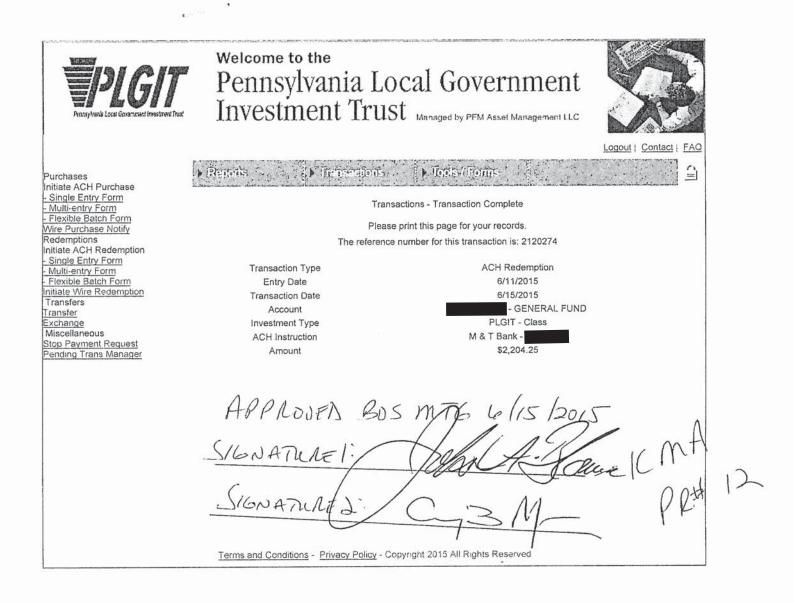

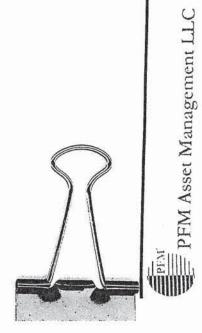
