A. Fertility Pump Station:

Mr. Cichy gave an update on the progress of the pump station. Construction continues. At the current time the driveway is being completed and work on the interior continues. All pumps are estimated to be installed and running by early November. The members of the Sewer Authority will take a trip to look at the site after it is fully operational.

Mr. Cichy presented change order #4 in the amount of \$2064.42, which consisted of a new chain hoist being put into place to replace the existing one. Additional floats and transducers were also placed in the wet well. A motion was made by Mr. Beaner to approve the change order. It was 2nd by Mr. Clark. Motion carried

A. Additional ELSA financing:

Mr. Hutchinson gave an update on the progress of the additional financing the ELSA is procuring. The Bond Counsel continues to put things together. A tentative October 25th Settlement date is set. Signatures will be needed prior to settlement from all Authority members.

B. Flow Monitoring.

Mr. Cichy gave a detailed explanation on flow rates over the past 2 years. He presented data from three different flow meters, they were Tennyson, Bridgeport and Susan Avenue. Some of the main points noted were the flow during a dry spell and also during a period of heavy precipitation.
