August 7, 2017

The East Lampeter Township Board of Supervisors met on Monday, August 7, 2017, at 7:30 pm. at the East Lampeter Township Office: 2250 Old Philadelphia Pike, Lancaster, PA 17602. The meeting was called to order by Mr. Dave Buckwalter, Chairman. In addition to Mr. Buckwalter, supervisors present were: Mr. Ethan Demme, Mr. Corey Meyer and Mr. Glenn Eberly. Absent was Mr. John Blowers. Also present was Mr. Ralph Hutchison, Township Manager.

The following persons signed in as being present in the audience:

Approval of the Minutes of the Monday, July 10, 2017 Regular Meeting

Chairman Buckwalter asked if there were any additions or corrections regarding the minutes of the July 10, 2017 regular meeting as prepared.

A motion was made by Mr. Meyer to dispense with the reading of the minutes and approve the minutes as presented. Mr. Eberly seconded the motion and it was passed unanimous voice vote.

Approval of Bills

Chairman Buckwalter presented the bills to be paid from various funds for the total amount of \$581,987.88. He discussed some of the larger items including a payment in the amount of \$199,763.69 to Pennsy Supply Inc. for in place paving materials and ADA adjustments, a payment in the amount of \$8,212.00 to Lancaster County District Attorney for Drug Task Force contribution #2 for 2017, a payment in the amount of \$11,838.00 to Highway Materials for asphalt materials to repair horse tracks, a payment in the amount of \$5,600.00 to Durex Coverings Inc. for floor surfacing in the park bathrooms, and a payment in the amount of \$14,294.28 to LASA for second quarter 2017 sanitary sewer transportation charges.

A motion was made by Mr. Meyer and seconded by Mr. Demme to approve the payment of the bills as listed in the amount of \$581,987.88. The motion was passed by unanimous voice vote.

Old Business

a. Time Extension for Township Plan Review and Action: Devon's Creek Phase 2

Chairman Buckwalter asked if anyone was present for this agenda item. Mr. Jeff Rutt was present.

Chairman Buckwalter stated that the applicants engineer has provided a letter dated July 11, 2017 requesting a time extension until August 16, 2018. He stated that the Township engineer has provided a review comment letter dated April 27, 2016. He asked Mr. Rutt if there was any progress on the project. Mr. Rutt explained that they have been looking for options to solve the water issue and hope to have those solutions available to the Board in the next few weeks. He stated that otherwise there were no other major issues regarding the plan.

Mr. Meyer made a motion to approve a six month time extension for Township plan review and action for Devon's Creek Phase 2. Mr. Demme seconded the motion and it was passed by unanimous voice vote.

b. Request for Release of Financial Security: 113 Clover Heights Road

Chairman Buckwalter asked if anyone was present for this agenda item. No one was present.

Chairman Buckwalter stated that the Township engineer is recommending a full release of financial security in the amount of \$5,576.37 leaving a remaining balance of \$0.

Mr. Meyer made a motion to approve the request for full release of financial security for 113 Clover Heights Road in the amount of \$5,576.37 leaving a remaining balance of \$0. Mr. Demme seconded the motion and it was passed by unanimous voice vote.

c. Request for Release of Financial Security: 1602 Lincoln Highway East

Chairman Buckwalter asked if anyone was present for this agenda item. No one was present.

Chairman Buckwalter stated that the Township engineer is recommending a full release of financial security in the amount of \$72,908.50 leaving a remaining balance of \$0.

Mr. Demme made a motion to approve the request for full release of financial security for 1602 Lincoln Highway East in the amount of \$72,908.50 leaving a remaining balance of \$0. Mr. Meyer seconded the motion and it was passed by unanimous voice vote.

d. Request to Modify Recorded Plan: King - 419 Mount Sidney Road

Chairman Buckwalter asked if anyone was present for this agenda item. Mr. Adam Keller was present.

Mr. Keller from TeamAg stated that he did the original planning for the site. He stated that the modification that is being requested is for the access drive off of South View Drive that was approved on the original plan. He stated at the time of approval the types and sizes of truck traffic were unknown. He stated since the opening of the business it has been determined that the size of the trucks being used are smaller and they feel that the current driveway is adequate. He provide the Board with turning templates and requested that he modification to remove the addition of the access drive. Mr. Hutchison stated that if the driveway does not need to be built

then the related stormwater items do not need to be completed. He stated that there are other outstanding stormwater related issues due to the building of the barn and other improvements on the site. Mr. Keller stated that they are installing the basin and that the only outstanding item is an as-built survey. Mr. Eberly asked when the gravel was added to the driveway and if it goes onto the neighboring property. Mr. King replied the gravel was added approximately 5 years ago. Mr. Keller stated that the gravel is in the 14 foot ROW. Mr. Eberly asked how the chickens got onto the property. Mr. King stated that a semi-truck brought them.

Mr. Eberly made a motion to deny the request to modify the recorded plan for Henry King at 419 Mount Sidney Road. Mr. Meyer seconded the motion and it was passed by unanimous voice vote.

e. Request for Reduction of Financial Security: 2630 Old Philadelphia Pike

Chairman Buckwalter asked if anyone was present for this agenda item. No one was present.

Chairman Buckwalter stated that the Township engineer is recommending a release of financial security in the amount of \$14,902.71 leaving a remaining balance of \$3,000.00.

Mr. Demme made a motion to approve the request for release of financial security for 2630 Old Philadelphia Pike in the amount of \$14,902.71 leaving a remaining balance of \$3,000.00. Mr. Meyer seconded the motion and it was passed by unanimous voice vote.

f. Resolution re: Lincoln Highway Tax Increment Financing (TIF) Participation

Mr. Hutchison stated that prior to this meeting the East Lampeter Industrial & Commercial Development Authority took action to approve the Lincoln Highway Tax Increment Financing (TIF) project plan regarding how the TIF would work and the benefits of having a TIF. He stated that the plan contemplates that the governing bodies will act on resolutions to indicate their participation and their level of participation in the plan. He stated that this finance projects along Lincoln Highway and that the Supervisors would give a 100% participation level. He stated that it is a 20 year program. He stated that the final process is adopting an ordinance.

Mr. Meyer made a motion to adopt the resolution for the Lincoln Highway Tax Increment Financing Plan at 100% Township participation level as stated. Mr. Demme seconded the motion and it was passed by unanimous voice vote.

Other Business

a. Resolutions (3) Authorizing Execution of PADOT Green Light Go Grant Agreements

Mr. Hutchison stated that the Board authorized the Township previously to submit applications to the PADOT Green Light Go program which funds up to 80% for projects involving intersection improvements and traffic signals. He stated the Township submitted 3 applications and was awarded full-funding for all three projects. He reviewed the projects including 1) replacing the remaining control cabinets and upgrade the lights to match existing lights, 2) traffic signal improvements at the Old Philadelphia Pike and Horseshoe Road and 3) changes to the line striping at Lincoln Highway East and Strasburg Pike intersection to improve traffic flow.

Mr. Demme made a motion to approve the three resolutions authorizing execution of the PADOT Green Light Go Grant Agreements. Mr. Eberly seconded the motion and it was passed by unanimous voice vote.

b. MS4 Report

Mr. Hutchison stated that Ms. Kadwill has provided the Board with a review of MS4 projects. He stated that no questions or comments have come in regarding the Pollution Reduction Plan presented at the July 10, 2017 meeting. He stated that the construction of the basin retrofit project on the Township complex property has begun from back of the property to the front. He explained that most of the project will be completed by the fall but a few items will have to wait until spring. He stated that there is a meeting on August 10, 2017 with the Township's partnering municipalities (West Lampeter and Strasburg Borough) to finalize funding and scheduling for the Pequea Creek streambank and riparian buffer project which is being primarily funded by another DEP grant.

c. Authorization to sign DEP Agreement re: Pequea Creek Project

Mr. Hutchison stated that this project will be happening at the Mill Bridge Village Campground property. He stated that the Township is working with West Lampeter and Strasburg Borough to complete the project. He stated that the project will satisfy all of East Lampeter's pollution reduction requirements in the Pequea Creek watershed for the next 5 years. He stated that the finalization of the share of the costs based on the portion of the project approximately \$20,000.

Mr. Demme made a motion to approve the authorization to sign the DEP Agreement regarding the Pequea Creek Project. Mr. Meyer seconded the motion and it was passed by unanimous voice vote.

d. Resolution re: Disposition of Township Records

Mr. Demme made a motion to adopt the resolution for disposition of Township records. Mr. Eberly seconded the motion and it was passed by unanimous voice vote. **RESOLUTION #2017-21**
