#### March 5, 2018

The East Lampeter Township Board of Supervisors met on Monday, March 5, 2018 at 7:30 pm. at the East Lampeter Township Office: 2250 Old Philadelphia Pike, Lancaster, PA 17602. The meeting was called to order by Mr. Dave Buckwalter. In addition to Mr. Buckwalter, supervisors present were: Mr. Ethan Demme and Mr. John Blowers. Also present was Mr. Ralph Hutchison, Township Manager. Mr. Corey Meyer & Mr. Glenn Eberly were absent.

#### Public Comment (non agenda items)

Mr. Jason Logue of 150 American Ave., Lancaster PA 17602 was in attendance to discuss the issue of the trail along Mill Creek. Mr. Logue stated this is has been ongoing and is wondering why. Mr. Hutchison stated that he has allowed the issue to slip and will make efforts to get it resolved in the coming months. He also mentioned that Keystone has continued to be a challenging partner in this effort.

Mr. Dave Shaller of Crest Avenue was attendance and voiced his concerns about activities at 18 Crest Ave, 33 S. Eastland Dr., 25 S. Eastland Dr. & 149 S. Eastland Drive. He mentioned he has observed significant remodeling activity on the property and the bringing in of vehicles that need repair. Mr. Shaller's concern is that the occupant may be operating a busing in this residentially zoned area. Mr. Hutchison stated that the Township staff is following up to gather information about Mr. Shaller concern.

Chairman Buckwalter presented the bills to be paid from various funds for the total amount of \$795,026.08. He mentioned that \$240,348.05 was going to the City of Lancaster for quarterly

sanitary flow charges, \$16,424.00 to Lancaster County District Attorney for annual contribution to Drug Task Force, \$21,000 to New Holland Auto Group for police vehicle purchase (2018 Jeep Grand Cherokee) and \$8,178.82 to Eastern Salt Company for road salt.

Mr. Buckwalter also mentioned that PADOT Wash Facility requested a time extension until April 16, 2018 and a reduction of financial Security for the High Associates, 1861 Wm. Penn Way the township engineer is recommending a reduction of \$41,745.00 leaving a remaining balance of \$20,675.00.

Mr. Blowers made a motion to approve the consent agenda as presented. Mr. Demme seconded the motion and it was passed by unanimous voice vote.

#### 2017 Officer of the Year Presentation- Chief Zerbe

Chief Zerbe introduced Mr. Justin Kulp, President of the Leola Lions Club who presented the 2017 Officer of the Year Award to Sgt. Brian Cloonan.

#### Police Department 2017 Annual Report - Chief Zerbe

Chief Zerbe reviewed the highlights of the 2017 Annual Police Report. He recommend to the Board continue enforcement of the curfew ordinance and discussed future plans for the Police Department.

#### New Business

a. Paradise Concrete Land Development Plan #17-20: 2771 Lincoln Highway East

Mr. Tom Matteson representing applicant, L. Stoltzfus, LLC, is proposing to demolish the existing structures located at 2771 Lincoln Highway East and construct an approximately 24,508 SF building with associated parking and loading areas. A future 11,700 SF addition is also being proposed. The proposed use is a commercial building supply store. The water supply is private and public sewer will be utilized. The site acreage is approximately 4.86 acres and the site is located within the Village Commercial zoning district.

After a brief discussion a motion was made by Mr. Blowers to conditionally approve Paradise Concrete Land Development Plan 17-20: 2771 LHE as per notes from the Township Engineer David Miller/Associates dated February 22, 2018 including Item No 6 Park, Open Space & Greenway provision. Applicant will be discussing item No. 6 with staff in order to calculate for that amount. Mr. Demme seconded the motion and it was passed by unanimous voice vote. b. Request for Deferral to Leacock Township: 91 N. Soudersburg Road

Mr. Matteson representing applicants Samael S and Rachel S. Stoltzfus, 91 N. Souderburg Road, Gordonville PA said that they are requesting a deferral of Land Development and sewer planning to Leacock Township

A motion was made by Mr. Blowers to approve the request for deferral for Leacock Township, 91 N. Soudersburg Road subject to East Lampeter Township planning department review dated February 9, 2018 with section 3 planning review condition of approval for an easement over the flood plain for a buffer area. Mr. Demme seconded the motion and it was passed by unanimous voice vote.

#### Action Items:

a. Consideration of Bids for in place paving materials: various locations

Mr. Hutchison mentioned that sealed bids were received by the township for 2018 in place paving material. Martin Paving, Inc. bid for \$53,238.40 was the only bid we received for Oil & Chip Surface Treatment contract. There were four bids received for the in place paving materials contracts Pennsy Supply, Inc. being the low bidder at \$197,832.00. East Lampeter Township staff recommends award to these two contractors for those amounts.

A motion was made by Mr. Blowers to award the contracts to Martin Paving, Inc. & Pennsy Supply Inc. Mr. Demme seconded the motion and it was passed by unanimous voice vote.

b. Consideration of Bids for bridge maintenance work: Greenfield Road

Mr. Buckwalter mentioned there were three bids: Landscape Designs, Inc., J.P.S. Construction and Bi State Construction. Landscape Designs, Inc. was the low bidder at \$114,777.30 and that Township staff recommends award of the bridge maintenance work contract to them.

A motion was made by Mr. Blowers to award the contract for bridge maintenance work on the Greenfield Road to Landscape Designs, Inc. Mr. Demme seconded the motion and it was passed by unanimous voice vote.

c. Engineering Design Services Re: RACP project - Rockvale Trail

Mr. Hutchison mentioned that the Township was successful with having an and RACP grant awarded back in late December the project which is called the Rockvale Trail which is on the farther eastern section of the corridor roughly from the intersection at the American Music theatre's traffic signal going east to Route 896.

The project was also anticipated to include the development of a portion of the recommended onroad bike network (S. Willowdale Drive, Rockvale Road and Rt. 896) and the conversion of the large stormwater detention basin as a water quality demonstration project. The original project was about 1.6 million dollars and we were awarded \$500,000 which only makes up total project of \$1 million. So the project will be have to be pared back to fit this budget amount.

A motion was made by Mr. Blowers to grant McMahon Associates the conceptual design work for the Rockvale Trail on the RACP project in the amount \$8,200.00. Mr. Demme seconded the motion and it was passed by unanimous voice vote.

d. Resolution Re: Change to Non Uniformed Employees' Pension contribution rate Mr. Hutchison stated that there are provisions in the current AFSCME agreement that we have with the Non-Uniformed bargaining unit that indicates that the employee contribution rate within the non-uniformed plan will go up or down depending on investment return results from the prior year. In 2017 the investment performance resulted in a return of over 14%. This amount would trigger a 6% reduction in the contribution rate as it is 6% more than 8% (1% more than 7%). However, as the current contribution rate is 3.5 and the agreement requires a minimum of 1% contribution rate, the rate is indicated to be 1%.

A motion was made by Mr. Blowers to adopt the Resolution to change the non-uniformed Employees' Pension contribution rate to 1%. Mr. Demme seconded the motion and it was passed by unanimous voice vote.

#### Resolution #2018-07

#### Manager's Report:

a. MS4 Report

Mr. Hutchison mentioned that Charity has provided a summary of current MS4 activities. Pequea Creek Mill Bridge project is in design right now. ELT's Basin retrofit project will wrap up in the next couple of months. Continuing with outfall inspections. Mr. Hutchison also mentioned that he has participated in meeting which are working toward the organization of a stream clean up along the Conestoga River in June.

b. Draft Noise Ordinance discussion

Mr. Hutchison stated that revisions have been made to the draft ordinance which was discussed by the Board back in December. The changes consist of removing the prohibition of residential construction activities on Sundays and Holidays and added a specific item to prohibit noise making fireworks between the hours of 10 pm and 7 am the following day. Mr. Hutchison mentioned that there was previous discussions about looking to go with using decibel measuring devices. Staff continues to feel that this is a good step to start with to see if it is effective.

Neighbors form the Drexel Avenue area were attendance to discuss their concerns about a neighbor who uses noise devices to "scare away" animals. They were looking to have an ordinance to address their concerns.

A motion was made by Mr. Demme to advertise the draft noise ordinance with the modifications for staff to create the setting of start and end time of the items listed and make it as similar to the neighboring ordinances as possible. Also to add provisions of snow blowers within 24hrs of a snow event. Mr. Blowers seconded and it was passed by unanimous voice vote.

#### Adjournment

A motion was made by Mr. Demme and seconded by Mr. Blowers to adjourn the meeting. The motion was passed by unanimous voice vote. The next regularly scheduled meeting is to be held on Monday, March 19, 2018 beginning at 7:30 pm.






