#### TOWNSHIP OF EAST LAMPETER

Lancaster County, Pennsylvania

A RESOLUTION OF THE TOWNSHIP OF EAST LAMPETER, LANCASTER COUNTY, PENNSYLVANIA, ACCEPTING AMERICAN AVENUE, HERITAGE ROAD AND LANTERN LANE LOCATED IN THE FALLS AT OLDE MILL SUBDIVISION, AS PART OF THE PUBLIC ROAD SYSTEM OF EAST LAMPETER TOWNSHIP.

WHEREAS, a plan of American Avenue, Heritage Road and Lantern Lane located in the Falls at Olde Mill subdivision, has previously been submitted to and approved by the Board of Supervisors of East Lampeter Township; and

WHEREAS, American Avenue, Heritage Road and Lantern Lane located in the Falls at Olde Mill subdivision, have been constructed in accordance with such approved plan which was recorded in Subdivision Plan Book <u>J218</u>, Page <u>00089</u>, in the Recorder's Office in and for Lancaster County, Pennsylvania.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of East Lampeter Township, Lancaster County, Pennsylvania, as follows:

- 1. American Avenue, as described in Exhibit "A" which is attached hereto and incorporated herein by reference, shall be and hereby becomes a part of the public road system of East Lampeter Township.
- 2. American Avenue begins at the centerline intersection with Heritage Road, ends at its beginning point, is 2858.42 feet in length and has a right-of-way width of 50 feet and a cartway width of 34 feet.
- 3. Heritage Road, as described in Exhibit "B" which is attached hereto and incorporated herein by reference, shall be and hereby becomes a part of the public road system of East Lampeter Township.

4. Heritage Road begins at the centerline intersection with American Avenue at the portion of American Avenue that fronts land owned by Raymond E. Good and Mary E. Good (Lot 54) and land owned by Jason T. Willner and Lorinda K. Willner (Lot 55), ends at the north easterly right-of-way line of Strasburg Pike (SR 2029), is 1146.02 feet in length and has a right-of-way width of 50 feet and a cartway width of 34 feet.

5. Lantern Lane, as described in Exhibit "C" which is attached hereto and incorporated herein by reference, shall be and hereby becomes a part of the public road system of East Lampeter Township.

6. Lantern Lane begins at the centerline intersection of American Avenue at the portion of American Avenue that fronts land owned by Thomas E. Dahlstrom and Elizabeth A. Weichler (Lot 30), ends at the northerly tract boundary, is 344.62 feet in length and has a right-of-way width of 50 feet and a cartway width of 34 feet.

7. A draft of American Avenue, Heritage Road and Lantern Lane is attached hereto as Exhibit "D" and made a part hereof, in accordance with Section 2316 of the Second Class Township Code.

8. The proper officials of the Township are hereby authorized to do and perform all acts necessary and required under the Second Class Township Code and the Act of Assembly Allocating Fuel Taxes to Municipalities (72 P.S. §2615.1 et seq.) to accept such streets as part of the public road system of East Lampeter Township.




