#### TOWNSHIP OF EAST LAMPETER

Lancaster County, Pennsylvania

A RESOLUTION OF THE TOWNSHIP OF EAST LAMPETER, LANCASTER COUNTY, PENNSYLVANIA, ACCEPTING COACH LIGHT LANE (EAST), COACH LIGHT LANE (WEST), PORTER WAY, GONDOLA DRIVE AND ADDITIONAL RIGHT-OF-WAY FOR HARTMAN STATION ROAD LOCATED IN PHASES II AND III OF THE HARTMAN STATION SUBDIVISION AS PART OF THE PUBLIC ROAD SYSTEM OF EAST LAMPETER TOWNSHIP.

WHEREAS, plans for Coach Light Lane (East), Coach Light Lane (West), Porter Way, Gondola Drive and additional right-of-way for Hartman Station Road located in Phases II and III of the Hartman Station Subdivision have been submitted to and approved by the Board of Supervisors of East Lampeter Township; and

WHEREAS, Coach Light Lane (East), Coach Light Lane (West), Porter Way, Gondola Drive and additional right-of-way for Hartman Station Road located in Phases II and III of the Hartman Station Subdivision have been constructed in accordance with such approved plans.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of East Lampeter Township, Lancaster County, Pennsylvania, as follows:

1. Coach Light Lane (East), as described in Exhibit "A" which is attached hereto and incorporated herein by reference, shall be and hereby become a part of the public road system of East Lampeter Township.

- 2. Coach Light Lane (East) begins at its intersection with Porter Way and ends at the Upper Leacock Township boundary line, is approximately 1,151.02 feet in length, has a right-of-way width of 50 feet and has a cartway width of 28 feet.
- 3. Coach Light Lane (West), as described in Exhibit "B" which is attached hereto and incorporated herein by reference, shall be and hereby become a part of the public road system of East Lampeter Township.
- 4. Coach Light Lane (West) begins at Porter Way and ends at the Hartman Station Development western property boundary, is approximately 135 feet in length, has a right-of-way width of 50 feet and has a cartway width of 28 feet.
- 5. Porter Way, as described in Exhibit "C" which is attached hereto and incorporated herein by reference, shall be and hereby become a part of the public road system of East Lampeter Township.
- 6. Porter Way begins at Coach Light Lane and ends at the Upper Leacock Township boundary, is approximately 1,925.11 feet in length, has a right-of-way width of 50 feet and a cartway width of 28 feet.
- 7. Gondola Drive, as described in Exhibit "D" which is attached hereto and incorporated herein by reference, shall be and hereby become a part of the public road system of East Lampeter Township.
- 8. Gondola Drive begins at Coach Light Lane and ends at Porter Way, is approximately 484.88 feet in length, has a right-of-way width of 50 feet and a cartway width of 28 feet.
- 9. A plan depicting the roadways described in this resolution is attached as Exhibit "E" in accordance with Section 2316 of the Second Class Township Code.

10. The proper officials of the Township are hereby authorized to do and perform all acts necessary and required under the Second Class Township Code and the Act of Assembly Allocating Fuel Taxes to Municipalities (72 P.S. §2615.1 et seq.) to accept such streets as part of the public road system of East Lampeter Township.
