## RESOLUTION NO. 2018-20

## RESOLUTION ESTABLISHING THE LIST OF RECYCLABLE MATERIALS UNDER THE ORDINANCE ESTABLISHING A RECYCLING PROGRAM WITHIN EAST LAMPETER TOWNSHIP

WHEREAS, the Board of Supervisors of East Lampeter Township, on or about the date hereof, adopted an ordinance which amended Ordinance 258 and which amendment authorized the Board of Supervisors to establish, from time to time, a list of recyclable materials; and

WHEREAS, the Board of Supervisors desires to adopt the following resolution establishing the list of recyclable materials for the owners and occupants of various residential and commercial properties within East Lampeter Township.

NOW THEREFORE, be and it is hereby resolved that the following responsibilities for source separating recyclable materials are established, consistent with Section 6 of the Ordinance Establishing a Recycling Program within East Lampeter Township, Ordinance 258, and with the amendment to such ordinance being adopted on or about the date hereof:

- A. Each person who owns or occupies a residential unit shall source separate the following recyclable materials:
  - 1. Clear, green or brown glass bottles and jars after residue has been rinsed out and any lids discarded.
  - 2. Aluminum, steel or other metal food and beverage cans after residue has been rinsed out and lids have been removed.
  - 3. Plastic bottles, jars and jugs which have necks and after any residue or lids have been discarded.
  - 4. Flattened Corrugated cardboard having no grease or food remnants and after removing any styrofoam, peanuts, bubble wrap, plastic liner or similar packing material.
  - 5. Yard waste (leaf waste).
  - 6. Tires.
  - 7. White goods.
- B. Each person who owns or occupies a multi-family unit shall source separate the following recyclable materials:
  - 1. Clear, green or brown glass bottles and jars after residue has been rinsed out and any lids discarded.
  - 2. Aluminum, steel or other metal food and beverage cans after residue has been rinsed out and lids have been removed.

- 3. Plastic bottles, jars and jugs which have necks and after any residue or lids have been discarded.
- 4. Flattened Corrugated cardboard having no grease or food remnants and after removing any styrofoam, peanuts, bubble wrap, plastic liner or similar packing material.
- 5. Yard waste (leaf waste).
- 6. Tires.
- 7. White goods.
- C. Each person who owns or occupies a non-residential unit shall source separate the following recyclable materials:
  - 1. Clear, green or brown glass bottles and jars after residue has been rinsed out and any lids discarded.
  - 2. Aluminum, steel or other metal food and beverage cans after residue has been rinsed out and lids have been removed.
  - 3. Plastic bottles, jars and jugs which have necks and after any residue or lids have been discarded.
  - 4. Yard waste (leaf waste).
  - 5. High grade office paper.
  - 6. Flattened Corrugated cardboard having no grease or food remnants and after removing any styrofoam, peanuts, bubble wrap, plastic liner or similar packing material.
  - 7. Tires.
  - 8. White goods.
- D. Each person or group of people who hold or sponsor community activities shall source separate the following recyclable materials:
  - 1. Clear, green or brown glass bottles and jars after residue has been rinsed out and any lids discarded.
  - 2. Aluminum, steel or other metal food and beverage cans after residue has been rinsed out and lids have been removed.
  - 3. Plastic bottles, jars and jugs which have necks and after any residue or lids have been discarded.
  - 4. Yard waste (leaf waste).
  - 5. High grade office paper.
  - 6. Flattened Corrugated cardboard having no grease or food remnants and after removing any styrofoam, peanuts, bubble wrap, plastic liner or similar packing material.
  - 7. Tires.
  - 8. White goods

This resolution is intended to be updated from time to time as and when the Lancaster County Solid Waste Management Authority policies for recyclable materials change.
