A RESOLUTION OF THE TOWNSHIP OF EAST LAMPETER, LANCASTER COUNTY, PENNSYLVANIA, ACCEPTING A RIGHT OF WAY LOCATED NEAR THE SOUTHWEST CORNER OF THE INTERSECTION OF HARTMAN BRIDGE ROAD AND ROCKVALE ROAD AS PART OF THE PUBLIC ROAD SYSTEM OF EAST LAMPETER TOWNSHIP.

WHEREAS, a preliminary/final subdivision and land development plan titled "2 Lot Subdivision- Sarah B. Beiler" was submitted to and approved by the Board of Supervisors of East Lampeter Township (the "Township") and recorded in the Recorder of Deeds Office in and for Lancaster County, Pennsylvania on January 25, 2002 at Plan Book J-212-74 (the "Plan"), a copy of which is attached hereto as Exhibit "A" and incorporated herein by reference;

WHEREAS, pursuant to and as depicted on the Plan, a portion of the property located at 46 Hartman Bridge Road, Ronks, PA 17572 (the "Property"), currently owned by Amos K. and Barbara K. King, formerly owned by Sarah B. Beiler and Jonas L. Beiler (deceased), was offered for dedication as a right of way in favor of the Township (the "Right of Way");

WHEREAS, the relevant improvements to the Property have been constructed in accordance with the Plan.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of East Lampeter Township, Lancaster County, Pennsylvania, as follows:


1. The Right of Way along Rockvale Road (T-537), as depicted on the Plan, shall be and hereby is accepted by the Township and shall become part of the public road system of the Township in accordance with Section 2316 of the Second Class Township Code.

2. The proper officials of the Township are hereby authorized to do and perform all acts necessary and required under the Second Class Township Code and the Act of Assembly Allocating Fuel Taxes to Municipalities (72 P.S. 2615.1 et seq.) to accept the Right of Way as part of the public road system of East Lampeter Township.

DULY ADOPTED the 17<sup>th</sup> day of June, 2019, by the Board of Supervisors of East Lampeter Township, Lancaster County, Pennsylvania, in lawful session duly assembled.


