

ORDINANCE NO. 116

AN ORDINANCE OF THE TOWNSHIP OF EAST LAMPETER,  
LANCASTER COUNTY, PENNSYLVANIA, REGULATING  
TRAFFIC AND PARKING IN THE TOWNSHIP AND  
REPEALING ALL PRIOR ORDINANCES INCONSISTENT  
THEREWITH.

The Township of East Lampeter hereby ordains and enacts  
as follows:

ARTICLE I

General Regulations

Section 1. Definitions and Interpretation.

(a) Words and phrases, when used in this ordinance,  
except for sections or articles to which different or additional  
definitions apply, shall have the meanings ascribed to them in the  
Vehicle Code (the Act of June 27, 1976, P.L. 162 No.81) as  
amended, except that, in this Ordinance, the word "street" may be  
used as the word "highway" as defined in the Vehicle Code.

(b) The term "legal holidays" as used in this Ordinance  
shall mean and include: New Year's Day, Memorial Day,  
Independence Day, Labor Day, Thanksgiving Day and Christmas Day.

(c) In this ordinance, the singular shall include the  
plural, the plural shall include the singular, and the masculine  
shall include the feminine.

Section 2. Manner of Adopting Permanent Traffic and  
Parking Regulations.

All traffic and parking regulations of a permanent  
nature shall be enacted as ordinances or as parts of ordinances or  
as amendments to ordinances of the Township of East Lampeter,  
except where the law specifically authorizes less formal action.

Section 3. Temporary and Emergency Regulations.

(a) The Board of Supervisors shall have the following powers to regulate traffic and parking temporarily and in time of emergency:

(1) In the case of fire, flood, storm or other emergency, to establish temporary traffic and/or parking regulations; and

(2) In the case of emergency public works or public events of limited scope or duration, to restrict or prohibit traffic and/or parking in limited areas for periods of not more than 72 hours.

(b) These temporary and emergency regulations shall be enforced by the Board of Supervisors and the Police Department in the same manner as permanent regulations. Any person who drives or parks a vehicle in violation of any regulation shall be guilty of a violation and, upon conviction, shall be liable to the penalty set out in the law or elsewhere in this ordinance for a violation of that nature, and, in case of a violation for which no specific penalty is set out in the law or elsewhere in this Ordinance, to a fine of \$25 and costs.

Section 4. Experimental Regulations.

The Board of Supervisors may, from time to time, designate places upon and along the streets in the Township of East Lampeter where, for a period of not more than 90 days, specific traffic and/or parking regulations, prohibitions and restrictions shall be in force and effect, and shall designate those locations by proper signs and markings. Those regulations,

prohibitions and restrictions shall be effective just as if they had been specified in this ordinance. No person shall drive or park a vehicle in violation of any such regulations, prohibition or restriction, and no person shall move, remove, destroy or deface any sign or marking erected, posted or made by authority of this section. Any person who violates any provision of this section shall, upon conviction, be liable to the penalty set out in the law or elsewhere in this Ordinance for a violation of that nature, and, in case of a violation for which no specific penalty is set out in the law or elsewhere in this Ordinance, to a fine of \$25 and costs. Provided: the purpose of this section is to allow for test and experimental determination of the feasibility and desirability of permanent changes in the ordinances of the Township of East Lampeter relative to traffic and parking.

Section 5. Traffic on Street Closed or Restricted for Construction, Maintenance or Special Events.

(a) The Board of Supervisors shall have authority to close any street or specific part of a street to vehicular traffic and to place barriers or station police officers at each end of the closed portion, while construction or maintenance work is under way or a special event is being conducted on the closed portion. It shall be unlawful for any person to drive a vehicle upon any such closed portion.

(b) The Board of Supervisors shall have authority to establish a restricted traffic area upon any street where construction or maintenance work is under way and to station flagmen at each end of the restricted portion. It shall be



unlawful for any person to drive a vehicle upon any such restricted traffic area at any time when the flagman is displaying a sign directing that vehicle to stop, or is signaling that vehicle, by a flag or other device, not to proceed.

(c) Any person who violates any provision of this section shall, upon conviction, be sentenced to pay a fine of \$25.00 and costs.

Section 6. Use of Streets By Processions and Assemblages.

(a) For the purpose of this section, the words "assemblage" and "procession" shall have the following meanings:

Assemblage: a gathering of people without vehicles, which interferes with the movement of pedestrian or vehicular traffic on any street;

Procession: a group of individuals, vehicles, animals and/or objects moving along a street in a way that interferes with the normal movement of traffic. A procession shall not include a funeral caravan or military convoy.

(b) It shall be unlawful for any person to hold or participate in any assemblage unless the person organizing or conducting the assemblage first obtains a permit from the Board of Supervisors, which shall be issued without fee. Application for the permit shall be made at least one week in advance of the day on which the assemblage is proposed to be held, but in any case where a state-designated highway is proposed to be used, application shall be made at least three (3) weeks in advance of the proposed date. The permit shall state the place where and the



date when the assemblage is to be held, and the hour when the assemblage may convene and the hour by which it shall have been completely dispersed. It shall be unlawful for any person to hold or to participate in any assemblage unless the permit has been granted, or at any time or place other than that authorized by the permit.

(c) It shall be unlawful for any person to hold or participate in any procession unless the person organizing or conducting the procession first obtains a permit from the Board of Supervisors, which shall be issued without fee. Application for the permit shall be made at least two (2) weeks in advance of the day when the procession is proposed to be held, but in any case where a state-designated highway is proposed to be used, application shall be made at least three (3) weeks in advance of the proposed date. The permit shall specify the date on which the procession is to be held, the route to be followed by the procession, the hour when and place where participants may commence to assemble and form before the procession is under way, the time when the procession may commence to move its route, and the time by which the end of the procession shall have reached the end of the route of the procession and the procession shall have been disbanded. It shall be unlawful for any person to hold or to participate in any procession unless the permit shall have been granted, or under any conditions as to time or route or otherwise than those stated in the permit.

(d) Any person who violates any provision of this section shall, upon conviction, be sentenced to pay a fine of \$25

and costs.

Section 7. Authority of Police Officers.

The Police Officers of the Township of East Lampeter shall have authority to direct traffic on the streets in the Township at intersections in public and in other places where the Vehicle Code or this ordinance applies.

ARTICLE II

Traffic Regulations

Section 1. Maximum Speed Limits Established on Certain Streets.

(a) Maximum speed limits are hereby established on portions of specified streets, as follows, and it shall be unlawful for any person to drive a vehicle on any part of a street where a maximum speed limit applies at a higher speed than the maximum prescribed for that part of the street:

(b) Any person who violates any provision of this section shall, upon conviction, be sentenced to pay a fine of \$35. Any person exceeding the maximum speed limit by more than five (5) miles per hour shall pay an additional fine of \$2 per mile for each mile in excess of five (5) miles per hour over the maximum speed limit.

Section 2. Electronic Traffic Signals at Certain Locations.

(a) At the following locations, traffic signals as indicated below shall be erected (or are ratified if previously erected), and traffic at those locations shall be directed by



those signals:

(b) Any driver of a vehicle who disobeys the directions of any traffic signal shall, upon conviction, be sentenced to pay a fine of \$25 and costs.

Section 3. Intersections Where Turn Prohibited on Red Signal.

(a) The following are established as intersections where drivers of vehicles headed in the direction or directions indicated are prohibited from making a right turn (or a left turn from a one-way street into another one-way street) on a steady red signal:

(b) Any driver of a vehicle who violates any provision of this section shall, upon conviction, be sentenced to pay a fine of \$25 and costs.

Section 4. One-Way Roadways Established.

(a) The following are established as one-way roadways and it shall be unlawful for any person to drive a vehicle upon a one-way roadway other than in the direction established for traffic upon that roadway:

(b) Any person who violates any provision of this section shall, upon conviction, be sentenced to pay a fine of \$25 and costs.

Section 5. Through Highways Established.

(a) The following highways are established as through highways, thus authorizing stop or yield signs to be erected facing traffic approaching every intersection with the through highway except for those intersections with traffic signals, or with exceptions or modifications as indicated below. Every driver of a vehicle approaching a stop or yield sign authorized by this section shall stop the vehicle or yield the right-of-way as required by Section 3323(b) and 3323(c) of the Vehicle Code, as the case may be, and shall not proceed into or across the through highway until he has followed all applicable requirements to that section of the law:

6. Mt. Sidney Road	From Old Philadelphia Pike north to Horseshoe Road
7. New Holland Pike	From the Conestoga River east to the East Lampeter Township-Upper Leacock Township boundary line

11. Strasburg Pike	From the Lincoln Highway East north to the East Lampeter Township-West Lampeter Township boundary line

(b) Any person who violates any provision of this section shall, upon conviction, be sentenced to pay a fine of \$25 and costs.

#### Section 6. Stop Intersections Established.

(a) The following intersections (in addition to intersections with the through highways established by Section 5 of this article) are established as stop intersections, and official stop signs shall be erected (or are ratified if previously erected) in such a position as to face traffic approaching the second-named street (the intersecting or through street) on the first-named street (the stop street) in the direction or directions indicated for that intersection. Every driver of a vehicle approaching the intersection on the first named or stop street, in the direction indicated in each case, shall stop the vehicle as required by Section 3323(b) of the Vehicle Code, and shall not proceed into or cross the second-named or intersecting or through street until he has followed all applicable requirements of that section of the law:

(b) Any person who violates any provision of this section shall, upon conviction, be sentenced to pay a fine of \$25 and costs.

Section 7. Yield Intersections Established.

(a) The following intersections (in addition to intersections with the through highways established by Section 5 of this article) are established as yield intersections, and

official yield signs shall be erected (or ratified if previously erected) in such a position as to face traffic approaching the second-named street (the through street) on the first-named street (the yield street) in the direction or directions indicated for that intersection. Every driver of a vehicle approaching the intersection on the first-named or yield street, in the direction indicated in each case, shall slow down or stop the vehicle as required by that subsection of the Vehicle Code.

Section 8. Turning at Certain Intersections Prohibited or Restricted

(a) It shall be unlawful for the driver of any vehicle, of the type indicated, traveling upon the first-named street at any of the following intersections, in the direction or directions indicated in each case, to make a left turn and/or a right turn into the second-named street, as indicated, at any time when such a turn is prohibited by this section:

### ARTICLE III

#### Stopping, Standing and Parking

##### Section 1. Vehicles to be Parked Within Marked Spaces.

Wherever a space is marked off on any street for the parking of an individual vehicle, every vehicle parked there shall be parked wholly within the lines bounding that space, and it shall be a violation of this article for any person to park a vehicle or allow it to remain parked otherwise.

##### Section 2. Parking Prohibited at all Times in Certain Locations.

(a) Parking shall be prohibited at all times in certain locations. Parking shall be prohibited at all times in the following locations:

#### ARTICLE IV

##### Weight, Size, and Road Restrictions

##### Section 1. Vehicle Weight Limits Established on Certain Streets and Bridges.

(a) On the following bridges and streets or parts of streets, by authority granted by Section 4902(a) of the Vehicle Code, it shall be unlawful for any person or persons to drive any vehicle or combination having a gross weight in excess of the maximum prescribed below for that bridge or street or part of street, as the case may be:

(b) Any person who violates any provision of this section shall be prosecuted under Sections 4902(a) and 4902(g-1) of the Vehicle Code, and, upon conviction, shall be sentenced to pay a fine of \$150 plus \$150 for each 500 pounds, or part thereof, in excess of 3,000 pounds over the maximum allowable weight, and costs.

Section 2. Truck Traffic Restricted on Certain Streets.

(a) It shall be unlawful for any person to drive a vehicle other than a passenger car on any of the following streets or parts of streets:

Provided: nothing in this section shall prohibit any person from driving an emergency vehicle on any of those streets or parts of streets, or from driving on any of those streets or parts of streets a truck or other commercial vehicle making local deliveries to or pickups from premises located along that street or part of a street.

(b) Any person who violates any provision of this section shall, upon conviction, be sentenced to pay a fine of \$25 and costs.

## ARTICLE V

### Pedestrian Regulations

#### Section 1. Pedestrians to Obey Traffic-Control Signals.

At all locations in the Township of East Lampeter where

official traffic-control signals are installed, pedestrians, except where directed otherwise by pedestrian-control signals installed under Section 2 of this article, shall obey the directions of those traffic-control signals, as follows:

(a) When facing a green signal, a pedestrian may proceed across the roadway with a crosswalk;

(b) When facing a steady yellow signal, a pedestrian shall not start to cross the roadway;

(c) When facing a steady red signal, a pedestrian shall not enter the roadway.

Section 2. Penalty for Violation.

Any pedestrian who violates any provision of this article shall be guilty of a summary offense, and, upon conviction, shall be sentenced to pay a fine of \$5 and costs.

ARTICLE VI

General Parking Regulations

Section 1. Forty-eight (48) Hour Parking Limit.

No vehicle shall be allowed to remain parked on any township highway for a period longer than forty-eight (48) consecutive hours.

Section 2. Commercial Vehicle Parking Limitations.

No truck tractor, semi-trailer or nonmotorized mobile home or travel trailer nor any motorized motor home with a "registered gross weight" in excess of 5,500 pounds may be parked on any road, street, highway or right-of-way owned or maintained by the Township of East Lampeter of the Commonwealth of Pennsylvania within any residentially zoned district within the



confines of East Lampeter Township. For the purpose of this Section, in the event a street is bounded on one side by a Residential District and on the other by a non-residential district, the provisions of this Section shall be appropriate and apply to that street even though the boundary line of the district is situated in the middle of the street or on the residentially zoned side. Further, for the purpose of this Ordinance, the term "registered gross weight" shall mean that weight shown or reflected on a Certificate & Attestation relative to weight issued by the Department of Transportation, Bureau of Motor Vehicles and Licensing.

#### Section 3. Parking at Curb.

No vehicle shall be parked or stand except with its right wheels to the curb and with both the right front and right rear wheels thereof within ten inches of the curb. Provided that, when necessary to permit the proper loading or unloading of a commercial vehicle, permission may be granted by the Board of Supervisors to either the owner or tenant of the real property of the owner of the vehicle to park said vehicle at an angle for such purpose. Provided further that, on one-way streets vehicles may be parked with either the right or left side thereof to the curb when headed in the legal direction, unless parking on such side is otherwise prohibited herein.

#### Section 4. Parking at Garages or Driveways.

No vehicle shall be parked at any time in front of or opposite to any garage or driveway so as to prevent convenient ingress or egress thereto and therefrom.

Section 5. Parked Vehicles to be Registered.

No vehicle shall be parked at any time on any road, street or highway within the Township of East Lampeter, Lancaster, Pennsylvania without having a proper current registration plate, or current inspection sticker.

Section 6. Commercial Vehicle Repair or Maintenance Prohibited.

No commercial repairing, washing, oiling, or other work on vehicle shall be performed at any time on public highways of the Township of East Lampeter, except in the case of emergency repairs.

Section 7. Penalties.

Any person, firm or corporation violating any of the provisions of Article VI of this Ordinance shall, upon conviction thereof, be sentenced to pay a fine of not less than \$10.00 nor more than \$50.00, together with costs of prosecution which fine and costs shall be collected in the manner provided by law for the recovery of fines and penalties for the violation of Township Ordinances, and, in default thereof, shall be imprisoned in the Lancaster County Prison for a period not exceeding ten (10) days.

ARTICLE VII

Interpretation and Repeal

Section 1. Severability.

The provisions of this Ordinance shall be severable, and if any of its provisions shall be held to be unconstitutional, illegal, or otherwise invalid, that decision shall not affect the validity of any of the remaining provisions of this Ordinance. It

is declared as a legislative intent that this Ordinance would have been enacted had that unconstitutional, illegal or otherwise invalid provision not been included in the Ordinance.

Section 2. Provisions to be Continuation of Existing Regulations.

The provisions of this Ordinance, so far as they are the same as those of ordinances and regulations in force immediately before the enactment of this Ordinance, are intended as a continuation of those earlier ordinances and regulations, and not as new enactments. Nothing in this Ordinance shall affect any act done or liability incurred, or any suit or prosecution pending or to be instituted under any of those repealed or superseded ordinances or regulations.

Section 3. Repeal of Certain Prior Ordinances.

All prior ordinances of the Township of East Lampeter insofar as they deal with the regulation of traffic and/or parking are repealed and declared unenforceable insofar as they are inconsistent with or identical to any provision of this Ordinance. This Ordinance shall not be interpreted to repeal Ordinance No. 56 of 1976 of the Township of East Lampeter, Lancaster, Pennsylvania establishing and ordaining fire lane parking regulations and restrictions which ordinance is intended by the Supervisors to remain in full force and effect.

Section 4. Owner Responsible for Non-Moving Violations.

The owner of any vehicle, as determined from the vehicle registration plate, vehicle identification number or any other reasonable means, whether or not said owner was the operator of



such vehicle, shall nevertheless be responsible for and liable for any penalties imposed or violations stated under any and all sections of Article III of this Ordinance. Such responsibility shall not relieve the actual operator of such responsibility and all penalties may be assessed and collected from either.

Section 5. Vehicles registered in corporate, partnership or multiple names.

Whenever any vehicle is in violation of any sections or provisions of Article III of this Ordinance and such vehicle is determined to be registered in the name of and/or owned by a corporation, the president, vice-president, secretary, or other responsible officer of such corporation, as well as the operator thereof, shall be absolutely liable and responsible for any penalties imposed for any violations thereof regardless of whether or not such person was at the time the actual operator of said vehicle.

Where any vehicle is registered in the names of a partnership, any partner shall similarly be responsible for any violations of Article III, of this Ordinance without regard to whether or not such partner was the actual operator of the vehicle. Whenever a motor vehicle is registered jointly in the names of 2 or more persons, any and all registered owners of said vehicle shall be responsible for any violations of Article III of this Ordinance and any and all such registered owners may be owner or operator, if owner is not operator, but duplicate penalties may not be collected or prosecuted therefor, but no more than one penalty or fine shall be collected, from any such owner, for each such violation.

Section 6. Effective Date.

This Ordinance shall take effect five (5) days after its adoption by the Board of Supervisors of East Lampeter Township.
