EAST LAMPETER TOWNSHIP RESOLUTION NO. 2021- 04

RESOLUTION OF THE BOARD OF SUPERVISORS OF THE TOWNSHIP OF EAST LAMPETER, LANCASTER COUNTY, PENNSYLVANIA, PROVIDING FOR A CREDIT ON BILLS ISSUED FOR SANITARY SEWER SERVICE

WHEREAS, on December 21, 2015, the Board of Supervisors for East Lampeter Township adopted Resolution 15-21 amending the sewer rentals and charges for the use of sewer lines in the Township;

WHEREAS, the Governor of Pennsylvania issued a Proclamation of Disaster Emergency on March 6, 2020, pursuant to the Emergency Management Services Code, 35 Pa.C.S. § 7101 et seq., based upon the imminent threat of COVID-19 (novel coronavirus) pandemic; and

WHEREAS, in this time of business closures, widespread unemployment and uncertainty in the financial markets, the livelihoods of many constituents, residents, taxpayers in Lancaster County have been greatly diminished and are otherwise negatively impacted; and

WHEREAS, the Board of Supervisors desires to mitigate the ongoing economic impact of COVID-19 on Township taxpayers by providing some relief to sanitary sewer customers who have been and will continue to be affected by economic conditions stemming from the COVID-19 pandemic. Specifically, the Board desires to use its authority to issue a ten (10) percent credit on quarterly billings for sanitary sewer services in 2021; and

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE TOWNSHIP OF EAST LAMPETER, LANCASTER, PENNSYLVANIA, that a ten (10) percent credit shall be provided to all customers of the Township's sanitary sewer system on the quarterly bills issued for 2021 services. Specifically, the ten (10) percent credit shall be applied to the quarterly bills issued in April, July and October 2021 and January 2022.

AND BE IT FURTHER RESOLVED, that nothing herein shall be construed as to effect or modify any other bills for sewer charges within East Lampeter Township, nor shall it be intended to effect the existence of any past sewer charges, penalties, or interest thereon for sanitary sewer charges owing prior to January 2021.
