

**RESOLUTION NO. 2021 - 14**

**RESOLUTION OF THE TOWNSHIP OF EAST LAMPETER,  
LANCASTER COUNTY, PENNSYLVANIA, MAKING A  
SUPPLEMENTAL APPROPRIATION FOR EXPENDITURES  
WITHIN THE POLICE FORFEITURE FUND (04) FOR THE  
2021 FISCAL YEAR**

Background:

The Board of Supervisors has, on or about December 20, 2020, adopted the 2021 Budgets for all Township funds including the Police Forfeiture Fund (04). At that time, it was anticipated that grant funding would be available to pay for a portion of the costs associated with the development and implementation of a Body Worn Camera (BWC) program within the Police Department. An application for grant funding was submitted jointly with other Lancaster County Police Departments, however funding was denied. Therefore, in order to make it possible to develop and implement a BWC program, additional dollars from Fund 04 are required. These purchases are expected to improve officer efficiency, accountability and safety and would not be possible without the availability of these funds.

NOW THEREFORE, BE IT RESOLVED by the Board of Supervisors for the Township of East Lampeter, Lancaster County, Pennsylvania, as follows:

1. The Board of Supervisors hereby makes supplemental appropriations from the Police Forfeiture Fund (04) for the development and implementation of a Body Worn Camera program through the following expenditures:
2. Motorola Solutions - Wearable Cameras, related equipment and warranty costs:  
\$95,320.00

3. Insight - Camera program computer support equipment costs: \$17,157.83
4. Total appropriation not to exceed \$113,000
5. Current 2020 Fund 04 Budget Amount \$60,000
6. Requested additional funding = \$53,000 allocated to Account 04.410.740

This resolution and the requirements contained in it shall be effective immediately.


