

RESOLUTION NO. 2018-16

**RESOLUTION OF THE TOWNSHIP OF EAST LAMPETER,
LANCASTER COUNTY, PENNSYLVANIA, MAKING A
SUPPLEMENTAL APPROPRIATION FOR EXPENDITURES
WITHIN THE POLICE FORFEITURE FUND (04) FOR THE
2018 FISCAL YEAR**

Background:

The Board of Supervisors has, on or about December 18, 2017, adopted the 2018 Budgets for all Township funds including the Police Forfeiture Fund (04). At that time there was uncertainty regarding the amount of forfeiture funds that would be received during 2018. Therefore a limited number of expenditures were included in the adopted 2018 Budget. Since that time, forfeiture fund receipts have been received and deposited in the Police Forfeiture Fund (04) in amounts that would allow the Police Department to make purchases that were not anticipated at the time of budget adoption. These purchases are expected to improve officer efficiency and officer safety and would not be possible without the availability of these funds.

NOW THEREFORE, BE IT RESOLVED by the Board of Supervisors for the Township of East Lampeter, Lancaster County, Pennsylvania, as follows:

1. The Board of Supervisors hereby makes supplemental appropriations from the Police Forfeiture Fund (04) for the following expenditures:

- a. Jumper Batteries (2) - \$500 Account #04.410.241
- b. Faraday Bags, 1 set - \$500 Account #04.410.241
- c. Cell Phone Docking Stations (3) - \$150 Account #04.410.260
- d. V-Spec Speed Timing Device - \$1,500 Account #04.410.740
- e. Enradd Head Unit - \$1,500 Account #04.410.740
- f. Halon Fire Suppression System (server room) - \$16,000 Account #04.410.740
- g. Digital Camera, Lens and Case - \$2,000 Account #04.410.740

- h. Lafayette Polygraph Equipment - \$5,200 Account #04.410.740
- i. Evidence Room Storage Files - \$6,200 Account #04.410.740
- j. Replacement AED (2) - \$2,700 Account #04.410.740

Total of the above appropriations = \$36,250

2. This resolution and the requirements contained in it shall be effective immediately.
