A. Sanitary Sewer:

i. Stauffer Run Upgrade

Mr. Cichy informed that the contractor is still waiting for the MCC's to arrive sometime in May 2023. There is nothing new to report.

ii. Cedar Acres

Mr. Thomas informed that the work has been completed.

iii. Possible System Extension on Strasburg Pike

Mr. Thomas discussed the information gathered on the report dated 03/22/23 Strasburg Pike On Lot Systems. After a lengthy discussion, HRG will get some cost estimates and ideas how the sewers would be run in the area.

iv. Tree House Update

Mr. Thomas informed that he is waiting to hear back from Kline's in regard to the video of the lines.

B. Storm water: None.

New Business:

A. Sanitary Sewer:

i. City's Flow Monitoring Project

Mr. Cichy informed that 3 of the 5 City temporary flow meters will be removed at the end of the month. The 2 remaining flow meters will be kept at the ELSA Susan Ave. meter and the Bridgeport meter. The 2 flow meters have a history of inaccurate readings; therefore the Meter Guy has recommended to replace them at a cost of \$ 3,750.00 . This work will be done under the township maintenance. CDM draft exhibit shows that the Partners allocated capacity that the existing interceptors are sized properly and have excess capacity.

ii. Capital Projects

Motion 1st by Mr. Stumpf to approve the WWTP Dewatering Building Locker Room Escrow Agreement. The authority's share is 14.93%, which is \$7,465.00 2nd by Mr. Clark. Motion carried.

iii. Improvements Guarantee Devon Creek

Motion 1st by Mr. Clark to approve the reduction of the performance bond in the amount of \$121,091.85 with the remaining escrow balance of \$33,660.00. 2nd by Mr. Stoltzfus. Motion carried.

iv. Partners Meeting

Mr. Hutchison informed the board that the City treatment plan expansion may need to be done sometime around the year 2034. The City is already talking about it with the partners.

B. Storm Water:

i.Update on MS4 Program

Ms. Hitchens briefly updated the board that Mr. Siesholtz and Mr. Thomas had met with the Pet Resort. They are very much interested in the program.

ii. HACC Update

Ms. Hitchens updated on the HACC project. Motion 1st by Mr. Clark to proceed with opening bids for the 2100 Linear feet of stream restoration, subject to the easements needed for the project. 2nd by Mr. Stumpf. Motion carried.
