Old Business:

A. Sanitary Sewer:

i. Stauffer Run Upgrade

Mr. Cichy informed that the contractor has received the MCC's sections and the work has resumed. Due to the delay in equipment, the substantial completion schedule will be impacted. There will be a change order coming soon. The contractor hopes to finish sometime in January 2024.

ii. Possible System Extension on Strasburg Pike

Mr. Cichy informed that HRG has submitted the Request for ARPA funding-Second Route to the County of Lancaster County for this project. We are still waiting for a decision from the County. Mr. Thomas informed that resident at 161 Strasburg Pike would like to be included in the project. Mr. Cichy thought that cost would increase the project; however it should not impact the funding requested. Mr. Thomas will be collecting more information from the resident.

B. Storm water:

i. HACC Streambank Construction Project

Ms. Hitchens discussed the project and informed that waiting for the specialized to tell us the best time maybe somewhere in October 2023 to take the pictures.

Ms. Hitchens informed that the PRP submitted to DEP has not been opened yet and we are still waiting.

A. Sanitary Sewer:

i. City's Flow Monitoring Project

Mr. Thomas informed they are pulling the monitor meters. Mr. Hutchison is still waiting for the report from the City.

iii. Additional Funding ARPA dollars

B. Storm Water:

i. Update on MS4 Storm Sewer Camera Project

Mr. Thomas reported that the camera of the lines has been completed. They are preparing the report and should be receiving it for review soon. In the report there should be a priority outlined. During this they found a line had collapse and repair work is being done. Ms. Hitchens reported that there is about 455,000 linear feet of storm sewer pipe that the authority has to maintain.
