## ORDINANCE NO. <u>366</u> OF 2023

AN ORDINANCE OF THE TOWNSHIP OF EAST LAMPETER, LANCASTER COUNTY, PENNSYLVANIA, AMENDING ORDINANCE NO. 116 WHICH REGULATES TRAFFIC AND PARKING IN THE TOWNSHIP, BY AMENDING ARTICLE II, SECTION 1, SUBPARAGRAPH (a) OF SAID ORDINANCE TO ESTABLISH MAXIMUM SPEED LIMITS ON CERTAIN STREETS WITHIN THE TOWNSHIP.

WHEREAS, on September 14, 1987, the Township of East Lampeter adopted Ordinance No. 116, as amended, regulating traffic and parking in the Township and repealing all prior ordinances inconsistent therewith;

WHEREAS, the Board of Supervisors of East Lampeter Township wishes to amend Ordinance No. 116 for the purpose of establishing maximum speed limits on certain streets within the Township.

## BE AND IT IS HEREBY enacted and ordained as follows:

1. That Ordinance No. 116, Article II, Section 1, subparagraph (a), which establishes maximum speed limits on specified streets is amended to reflect the following:

Street	Between	Maximum Speed Limit
Clayton Avenue	Lincoln Highway East to Susan Avenue	25 miles per hour
Meadowview Avenue	From Clayton Avenue to the Township line	25 miles per hour
Plymouth Avenue	From Clayton Avenue to the Township line	25 miles per hour
Reese Avenue	From Lincoln Highway East to the Township line	25 miles per hour
Susan Avenue	From Clayton Avenue to Lincoln Highway East	25 miles per hour

- All other provisions of Ordinance No. 116, as amended from time to time, shall remain in full force and effect as heretofore adopted.
  - 3. This Ordinance shall become effective five (5) days after the date of its enactment.
