**RESOLUTION OF THE TOWNSHIP OF EAST LAMPETER,
LANCASTER COUNTY, PENNSYLVANIA, MAKING A
SUPPLEMENTAL APPROPRIATION FOR ESPENDITURES
WITHIN THE FIRE APPARATUS REPLACEMENT FUND (31) FOR THE
2023 FISCAL YEAR.**

Background:

The Board of Supervisors has, on or about December 19, 2022, adopted the 2023 Budgets for all Township funds including the Fire Apparatus Replacement Fund (31). At that time, it was anticipated the final reimbursement of 60% of Witmer Fire Company's cost to refurbish their tanker would be paid by the end of calendar year 2022. Thus, there was no anticipated disbursement out of Fund 31 during 2023 for Witmer Fire Company. However, due to delays in the refurbishment of the tanker, the remaining reimbursement was not made by the end of 2022. The refurbishment of the tanker was completed and Witmer Fire Company took delivery of the tanker at the end of March 2023. The original fire apparatus replacement schedule had Witmer Fire Company replacing their 30 year old tanker in 2024. Unfortunately, the tanker needed to be taken out of service during 2022. In an effort to save money and return the tanker to service more quickly, Witmer Fire Company chose to have their tanker refurbished. Since the replacement schedule did not have any apparatus being replaced in 2022, it was decided to move up the date for replacement of the tanker. The 2022 budget was amended via Resolution 2022-16 to provide for the reimbursement to Witmer Fire Company. During 2022, a deposit was made by Witmer Fire Company and the Township reimbursed 60% of the deposit.

NOW THEREFORE, BE IT RESOLVED by the Board of Supervisors for the Township of East Lampeter, Lancaster County, Pennsylvania, as follows:

1. The Board of Supervisors hereby makes a supplemental appropriation from the Fire Apparatus Replacement Fund (31) for the final reimbursement to Witmer Fire Company for the refurbishment of their tanker. The Township's share of the final cost of the refurbishment is \$71,208.07. Therefore, a supplemental appropriation of \$71,208.07 under Account # 31-411-743-000 is hereby made to provide for the Township's reimbursement.

This resolution and the requirements contained in it shall be effective immediately.
