

RESOLUTION NO. 2023 - 21

**RESOLUTION OF THE TOWNSHIP OF EAST LAMPETER,
LANCASTER COUNTY, PENNSYLVANIA, MAKING A
SUPPLEMENTAL APPROPRIATION FOR AN EXPENDITURE
WITHIN THE LIQUID FUELS TAX FUND FOR THE 2023 FISCAL YEAR.**

Background:

The Board of Supervisors has, on or about December 19, 2022, adopted the 2023 Budgets for all Township funds including the Liquid Fuels Tax Fund (35). At that time, it was anticipated that there would be no expenditure from these funds in 2023 for the purchase of a snow plow. The purchase of the snow plow was not budgeted to be made during 2022, but it was ordered during 2022. However, due to supply chain issues in various markets, the delivery of the snow plow did not happen during 2022. The snow plow was recently delivered to East Lampeter Township.

At the time the 2022 budget was adopted, it was anticipated that an existing snow plow was going to be used as an attachment to a new tractor which was budgeted for purchase during 2022. This tractor was only recently delivered to East Lampeter Township. When the tractor was ordered, it was learned that the existing snow plow would not be able to be attached to the new tractor. So, a new snow plow was ordered even though it was not budgeted as a purchase for 2022. With the supply chain issues, the snow plow was not delivered during 2022 nor were we sure when the snow plow would be delivered. Thus, we didn't include the snow plow in the 2023 budget. With an increase in the number of Public Works employees, the purchase of the new tractor was to provide an additional tractor to be used for plowing snow. Thus, the purchase of the new snow plow was needed to meet the needs for which the additional tractor was purchased.

NOW THEREFORE, BE IT RESOLVED by the Board of Supervisors for the Township of East Lampeter, Lancaster County, Pennsylvania, as follows:

1. The Board of Supervisors hereby makes a supplemental appropriation from the Liquid Fuels Tax Fund (35) for the following expenditure:

2. Stephenson Equipment, Inc. for the purchase of a new snow plow not to exceed \$19,000.

This resolution and the requirements contained in it shall be effective immediately.


