

## RESOLUTION NO. 2026-14

### RESOLUTION OF THE TOWNSHIP OF EAST LAMPETER, LANCASTER COUNTY, PENNSYLVANIA, MAKING A SUPPLEMENTAL APPROPRIATION FOR EXPENDITURES WITHIN THE GENERAL FUND FOR THE 2026 FISCAL YEAR.

#### Background:

The Board of Supervisors has, on or about December 15, 2025, adopted the 2026 Budgets for all Township funds including the General Fund. At that time, it was not anticipated that traffic signal equipment along the Route 30 corridor as well as other locations within the Township would fail to operate as normal or as intended. Traffic signal equipment that has already failed and within the means of the adopted budget, have already been fixed or are scheduled to be fixed. Other traffic signal equipment outside of the adopted budget that has failed, has yet to be fixed. These failures have resulted in significant traffic backups along the Route 30 corridor and a safety hazard along Mount Sidney Road with the Witmer Fire Company alert sign. To rectify this situation, additional repairs or replacement of equipment will be required. These failures have caused a complete expenditure of the budgeted amount for Traffic Signal Maintenance and Repairs and there will be additional expenditures in the near future in order to completely fix the traffic signal failures.

NOW THEREFORE, BE IT RESOLVED by the Board of Supervisors for the Township of East Lampeter, Lancaster County, Pennsylvania, as follows:

1. The Board of Supervisors hereby makes a supplemental appropriation from the General Fund for the additional expenditures to fix the remaining traffic signal equipment failures and to provide for additional normal/routine maintenance and repairs of all


other township traffic signals. The Township's share of these additional costs is estimated to be approximately \$64,000.00. Therefore, a supplemental appropriation of \$64,000.00 under Account # 01-433-372-000 (Account named "Maintenance/Repairs-Traffic signals") is hereby made to provide for the Township's estimated additional costs. This supplemental appropriation will bring the total budget for calendar year 2026 for this expenditure account to \$100,000.00

This resolution and the requirements contained in it shall be effective immediately.
